PURPOSE:

The purpose of the GTDAA Hall of Fame is to honor those individuals who have played a significant role in the growth and development of the Georgia Tire Dealers Association and the Tire Industry. Eligible nominees must be from GTDAA membership.

QUALIFICATIONS:

To qualify for induction, the nominee must have been a regular, associate or supplier member of the GTDAA in good standings for the period of contribution. Nominees should be outstanding contributors to the Tire Industry through personal achievement, leadership and by example.

RULES:

The annual quota for inductees will be two per year.

To be considered, candidates must have served within the Tire Industry and GTDAA or a minimum overall length of time totaling five years.

The Hall of Fame Committee will choose from the eligible applications.

The inductees will be announced and honored at the annual meeting every year.
