ATTORNEY'S CORNER

CATALYTIC CONVERTER THEFTS

As all repair shops in our area and throughout the nation, we all are aware that there has been a dramatic increase in catalytic converter thefts since 2019. The exponential growth of catalytic converter thefts is plaguing most cities across the nation.

Why are people stealing catalytic converters?

The catalysts in the gas-changing chemical reaction happen to be an assortment of metals which include platinum along with two other medals (and even more precious): rhodium and palladium. This makes the part very valuable, both in resale and scrap value.

As of Aug. 22, YS Catalytic Recycling, a catalytic converter recycler based in Albany, New York, will pay an average of \$336 per converter. As of Aug. 26, platinum is selling for about \$28 per gram, while palladium is going for \$68 per gram and rhodium \$448 per gram.

Checking around we are told that another reason catalytic converters are stolen so often is that they're easy to pull off. It is inexpensive to buy the tools required – just a Home Depot trip away – but it's also quick. Someone takes off a converter as quickly as 45 seconds.

It seems that most of the time, the thieves steal them and then pass them on to buyers or fences to fund a drug addiction.

According to a 2022 study, these are the 10 cars that are targeted most for these kinds of thefts nationwide:

Sophisticated Chop Shop

A "chop shop" is an illegal business that either dismantles stolen motor vehicles and distributes their parts, or uses the parts to build illegal motor vehicles, or sells the parts to a scrap yard. Simple definition and cat thefts blend right in. If the police catch a cat thief, and it is doubtful that they can since today, the police have their hands full of other types of crimes, such an arrest can often lead them to a chop shop.

EMPLOYEE RETENTION CREDIT

There are four ways to qualify for the ERC.

- Full or Partial Suspension shut down due to government order (order did not have to be given directly to you), applies mainly during 2020 since there were very few shutdowns during 2021.
- 2. Supply Chain Disruption must have resulted from a government order to your supplier, making them unable to deliver goods to you.
- Revenue Reduction 2020- 50% reduction of gross sales compared to same quarter of 2019; 2021-20% reduction of gross sales compared to same quarter of 2019.
- 4. Start Up Recovery Funds Started business after 2/15/20.

There are no up-front costs to apply!!! If and only if you get a credit back from the treasury, there will be a 15% recovery fee off of the total amount returned.

If you qualify you may be eligible for up to \$26,000.00 per W-2 employee. You can still receive your credit if you got the PPP.

It takes a few minutes to fill out the application. If you prequalify, you can move on to the regular application and begin the process for your rebate.

In 2 to 4 weeks, you will have an answer from Tax Rebate Specialists on the amount of your rebate!

WESTCHESTER COUNTY, N.Y. LEGISLATORS PASS FLAVORED TOBACCO BAN, SENDS BILL TO COUNTY EXECUTIVE

On November 28, 2020, the Westchester County Board of Legislators passed a bill that will ban the sale of flavored tobacco products in the county.

The bill includes a ban on the sale, distribution and marketing of all flavored tobacco products, including those with menthol, mint and wintergreen. It does not prohibit the use of such products within county lines, however.

"This is a positive step for public health in Westchester County," said Legislator Williams Johnson, sponsor of the bill and Chair of the Committee on Health, via a press release. "It is good policy and protects the vulnerable from continuing to be exploited by Big Tobacco. We seized an opportunity to shield our citizens, especially children from the challenges of nicotine addiction and related health risks. In passing this legislation, our Board has set an example for other jurisdictions to follow. The lives of our children and families are worth so much more than the millions of dollars tobacco manufacturers make from the intentional, long-term destruction of our communities."

The bill, which passed by an 11-6 vote, now heads to the desk of County Executive George Latimer, for his signature or veto. Latimer has not yet indicated his plans for the bill, other than that a spokesperson said he will review the bill. If signed into law, the bill would go into effect six months following its enactment.

If it goes into law, the county's health department will be tasked with enforcing the law, and retailers who violate the law will face a first-time fine of \$300, which can climb to \$1,500 for each subsequent violation within a two-year period. A third violation would result in the retailer losing its license for six months.

SUBJECT: 2024 STICKER ORDERING and NYVIP3 UPDATE

Inspection stickers with an expiration year of 2024 are now available to order.

HOW TO ORDER STICKERS:

To order stickers on the NYS DMV website go to

http://dmv.ny.gov/sticker/default.html.

Consistent with normal practice, it is each inspection station's responsibility to order next year's stickers promptly so that you have proper supply on hand by January 1, 2023. Sticker orders are processed in the order received. Please allow 3-4 weeks for processing.

The last day 2023 expiring sticker orders will be processed by DMV is December 22, 2022. Please submit your 2023 expiring sticker orders prior to this date.

Please note: these stickers will **not** be compatible with the NYVIP3 program. Any remaining stickers can be returned for credit once you begin using your NYVIP3 equipment. Please see below for additional information on NYVIP3.

NYVIP3 Update

Initial phase one beta testing is currently underway. (As a reminder, phase one stations include official diesel (opacity) inspection stations and those that haven't utilized NYVIP in the past (safety only).)

Production beta testing utilizing the new print on demand inspection sticker is scheduled to begin mid-December with full phase one rollout scheduled for mid-January. Phase two beta testing is also underway. (As a reminder, phase two stations will include all those that currently conduct inspections with a NYVIP2 computerized vehicle inspection system (CVIS).)

Phase two equipment orders must be submitted ASAP and shipping will begin this spring. Further information about phase two will be shared in early 2023.

Any station (phase one or two) that has not yet ordered equipment must proceed to WWW.NYVIP3.COM to register and complete your order with Opus Inspection Inc. as soon as possible. If you do not register and place an equipment order, you will be unable to meet the requirements to maintain a New York State vehicle inspection station license.

ADDITIONAL EQUIPMENT REQUIREMENT FOR USED MOTOR VEHICLES SOLD AT RETAIL (INFLATABLE RESTRAINT SYSTEM)

In February 2022 section 417 of the Vehicle and Traffic Law (VTL) was amended to add certification and equipment requirement for used motor vehicles sold at retail.

All used motor vehicles sold at retail must be equipped with an operational inflatable restraint system (air bags) which conforms to the applicable federal motor vehicle safety standard that was in effect on the date of manufacture. The air bag readiness indicator light must illuminate momentarily as the vehicle is being powered up and must not remain illuminated nor flash intermittently while the vehicle is being driven.

In addition, all invoices or bill of sales for all used motor vehicles sold at retail to contain the following statement:

"The dealer named above further certifies that this vehicle complies with the inflatable restraint system requirements found in section 419-a of New York state Vehicle and Traffic Law."

This statement must: (1) be of the same color, size and font as the used vehicle certification statement; and (2) immediately follow the used vehicle certification statement.
